Both **Grand** and **Gilpin County Commissioners** have been supportive of the reopening. Your Board believes the **Forest Service** and **Boulder County Commissioners** have been blocking all efforts to date.

Your message does not need to be long, but to the point. A brief sample letter follows. It is our understanding that all forms of contact on issues are counted and large numbers of constituents supporting a cause are more likely to bring a response. Out-of state interest is also a recognized bonus to the numbers. It is vital that you express your desire for support and enforcement of the federal James Peak Wilderness Act:

Public Law 107-216, 107<sup>th</sup> Congress, Section 7(b) of the James Peak Wilderness and Protection Area Act states:

*ROLLINS PASS ROAD. — If requested by one or more of the Colorado Counties of Grand, Gilpin, and Boulder, the Secretary shall provide technical assistance and otherwise cooperate with respect to repairing the Rollins Pass road in those counties sufficiently to allow two-wheel-drive vehicles to travel between Colorado State Highway 119 and U.S. Highway 40. If this road is repaired to such extent, the Secretary shall close the*

*motorized roads and trails on Forest Service land indicated on the map entitled "Rollins Pass Road Reopening: Attendant Road and Trail Closures, dated September 2001."*

Please don't expect someone else in the organization to champion the lack of government enforcement. We have played the political battle for too long. It is time for you, our members, to take action. Give your organization a few minutes **NOW!** It is past time for the road through our official historic landmark being open through the tunnel and the road up the East side of Carona Pass must be repaired and maintained before it is a total loss. RPPA is working in cooperation with Colorado Off - Highway Vehicle Coalition (COHVCO) for our mutual interests.

If you have other memberships or connections with like minded groups or organizations, please alert them to this miscarriage of justice and solicit their support.

Once you have made contact or left a message, please call or email one of the Co-Presidents so we can keep track of our lobbying efforts.

*As a citizen of the state of XX, I am concerned that Public Law 107-216, 107<sup>th</sup> Congress, Section 7(b) entitled, the James Peak Wilderness and Protection Area Act, sponsored by Senator Mark Udall and passed in 2002, has yet to be enforced. Please help OPEN THE ROAD and the historic Needles Eye Tunnel. The Forest Service and Boulder County have not cooperated with the law and thousands of people across Colorado and the nation want to know why?*

## 100 years ago on March 16, 1911 David Halliday Moffat Died

Moffat is buried in the historical Fairmount Memorial Cemetery, Denver along with many of Colorado's colorful founders. Moffat died at age 72 of heart disease complicated by a bout of pneumonia and grip in New York City. In 1860 Moffat traveled west and opened a book and stationery store with C.C. Woolworth. After working six years in retail, he saw his future in banking and

worked as cashier at the First National Bank of Denver. Fifteen years later David Moffat was elected President of the successful bank. He continued working in banking for the rest of his life. Moffat's interests and most of his money were the results his lifetime dedication to mining and railroads where he became a millionaire.


